David LaMontagne Presented the John D. Andrews Founder's Award



In memory and in honor of John D. Andrews, past Chairman and founding member of C-PORT, as well as a longtime leader of the assistance towing industry, C-PORT presented its inaugural John D. Andrews Founder's Award to David LaMontagne, founder of Vessel Assist Association of America and one of the original C-PORT founding board members. The award was given at the C-PORT Awards Banquet Gala on January 27, 2026.

Presenting the award was Phil LeBlanc, C-PORT chairman and co-owner of the company John Andrews created, Safe Sea. LeBlanc explained that John's extraordinary involvement in the forming and fostering of the assistance towing industry, decades of board service, and the mentorship of countless operators and businesses brought him many honors, awards, and recognition. "It is most fitting that this award be named after John, a man who gave back so much to the industry he helped to found. "

The Award is to be granted to those that have made an indelible positive impact on the assistance towing industry or C-PORT. It is not an annual or regular award. Instead, it is reserved for those who have demonstrated their passion for and dedication to the industry, through tireless service or exemplary acts of leadership.

"In this room are only a few individuals who were here from the very beginning. One of those led the way for an entire coast, and later, the country. Therefore, it is only fitting that the first ever John D. Andrews Founder's Award be presented to David LaMontagne," announced LeBlanc.

LaMontagne expressed he was overwhelmed and shocked when he heard his name from the podium and regrets not conveying his thoughts at that moment. He provided a statement in the hopes of showing his sincere thanks and gratitude for this high honor.

Statement from David LaMontagne on receiving the C-PORT John D. Andrews Founder's Award:

The awards and recognition of the evening should rightly go to the younger guys and gals in the room that are on the water, truly helping and saving people and building up their areas. So now it's one of the older guys in the room getting an award... it must be my age... haha

Then I started to have some memories of John, when I was the youngest guy the room, and our conversations... About then, as I was walking back to my table, I ran into Pete [Andrews]... and felt the emotion of it all...tearing up a tad. Pete was very genuine and sincere.

John and I would have these conversations over the years where we were learning from each other. I, the CA guy, had the Vessel Assist business plan and was very busy executing it and it was all about obtaining more service providers, selling memberships and expanding territory. The boats had to be a certain look, fast and meet a list of equipment and operational requirements, and operator's ideally the right temperament. He, on the other hand was this lanky older sometimes awkward Nw-England gent with a not so attractive Tug Kropp that could do 5 knots over a waterfall. Talk about approaching the business from different directions. But learn from each other we did.

John was outspoken on the need to be sure the industry did not water down the underpinning salvage law, and he was spot on. I've, of course, learned that initially from John, and others, and have taught the same to many a captain ever since.

John came to get a fleet of faster boats and grew the primary local membership program SafeSea. Plus, while a successful company from CA could send money to help out the fledging industry, we couldn't always show up at CG Headquarters and Capitol Hill for the necessary meetings to watch over the industry like John and others could do.

Now here I am, back to being the older guy in the room... Richard Schwartz has died and I was honored to become the first recipient of the BoatUS - Schwartz Founders Award. Joe [Frohnhofer] has passed on. And now my friend John, who I respected, is gone and I'm the first recipient of the C-PORT Founders Award - - in John's name. It's truly an honor and a total surprise to me to be honored after all these years when you guys on the water everyday, are the true heroes of our industry.

I've given much of my entire career and adult life to this industry and helped lay the backbone of what and who the industry is now. I'm so proud of you guys when I see the good work or hear stories from all over the US of the jobs well done. There is a humility and yet confidence in our ability to get the job done right and treat the customer right that I see in the culture of who this industry is, that I've felt important for our common success from day one. The industry is maturing before our very eyes but keep the humility and respect for the sea, and don't forget from the outside you're only as good as your last job, so do it well. I am profoundly appreciative to you all for this recognition.

39th C-PORT Conference and Membership Meeting Recap

C-PORT hosts a number of important partner meetings leading up to the opening of its Conference. One of those meetings is the **U.S. Coast Guard and C-PORT Partnership Meeting**. Due to the winter storm that grounded thousands of flights throughout the country, only one member of the Coast Guard leadership team was able to attend. Captain Matt Fine, Chief, Office of Shore Forces USCG, arrived later in the day, and was in attendance for the Partnership Dinner. The C-PORT Board of Directors and Captain Fine took that opportunity to discuss industry concerns as Fine provided US Coast Guard updates in preparation for his address to the membership on the following day.

C-PORT Board of Directors met with its insurance program partners on Monday, January 26, 2026. Travelers Ocean Marine underwrites the C-PORT program with Starkweather & Shepley Insurance Brokerage acting as the administrators. Attending from Travelers Ocean Marine were Lisbeth Ryan, AVP and Managing Director, and Mike Gozzo, underwriter. Representing Starkweather & Shepley's Marine Practice Group were Jay Frechette, Senior Vice President and Sara Mariani, account manager. They were joined by Charlie Pugliese, former president, Ocean Marine Practice Leader at Travelers Insurance. Charlie is now a marine consultant working with Starkweather & Shepley's marine practice group. Frechette presented the yearly program report to the board. Discussions continued regarding the program's success and financial health and stability of the program under Travelers, and developing the program for future growth.

The conference kicked off on Monday evening with a welcome reception. Attendees enjoyed connecting and reconnecting with their fellow operators, as well as conversing with U.S. Coast Guard partners, and industry sponsor supporters in a relaxed atmosphere. The evening was made complete with an open bar and artisanal cheeses displays.


Cardone provided C-PORT's U.S. Coast Guard Partnership Committee report, emphasizing the importance of the Memorandum of Understanding (MOU) that exists between U.S. Coast Guard and C-PORT. The agreement opens doors of communication and enhances the partner relationship between the parties. She thanked the Coast Guard, in particular CAPT Matt Fine, who worked with C-PORT to clarify a couple of policy variances that occurred over the past year.

Cardone highlighted three events that C-PORT was honored to be a part of, including the Retirement Ceremony for Jeffrey Wheeler, Deputy Chief, Office of Boat Forces USCG (now retired), the USCG Commandant's Holiday Party, and the USCG Commandant's Assumption of Command Ceremony.



Wheeler's retirement: Tina Cardone, Phil LeBlanc, Terry Hill, and Jeff and Tania Dziedzic joined the celebration honoring Jeff's 42 ½ years with the U.S. Coast Guard. As is Jeff's style, he wanted a celebratory affair and called for a roast rather than speeches about how great he is. LeBlanc and Cardone managed to do both. With Wheeler in the audience, Cardone said "Jeff, as I said at the retirement party, through it all, much work was done. Programs were created. Professionalism within the industry was raised. We thank you for your guidance over the past 15+ years."

A few weeks after Wheeler's retirement, Cardone and LeBlanc were back at Coast Guard Headquarters, attending the U.S. Coast Guard Commandant's Holiday Party. 

C-PORT held its Board of Directors Election at its 2026 Membership Meeting on January 27, 2026.
Richard Lenardson, owner Great Lakes Marine Services LLC, was elected to a second term by unanimous vote.



Rich started GLMS llc as an addition to Great Lakes Towing's Road Service. In 2008, Rich and his wife Jessica started their first marine port, Saint Joseph MI. The company has expanded to cover waters in 5 states from 16 listed TowBoatU.S. ports. His family has also grown with 6 children. While the marine and land services are now separate entities, he has learned much from his lifelong experience with road towing.

Rich maintains that marine assistance towing is a very small niche industry. He feels this exposes the industry to being very sensitive to any participating company's actions that could be seen as negative. In turn, all companies can be affected by a few that may not operate under certain safety and professional policies. He feels that C-PORT is offering the industry the needed guidance for safety and professional operations in the industry.

In his words, "I have seen many of the ups and downs of the road service industry that relate to marine assistance towing from safety, training, insurance relations, and interactions between companies in the industry. As well, my experience with towing and recovery can offer C-PORT and its members valuable insight into training programs and effective operating procedures for the industry. I am honored to serve as a board member and pass on any knowledge I have to the industry."

During the C-PORT Awards Banquet Gala later that evening, Tina Cardone, C-PORT executive director, released the names of the 2026 C-PORT board of directors and executive committee. She announced that Phil LeBlanc, currently serving as Chairman, had reached his term limits of service. According to the C-PORT Bylaws, LeBlanc was required to step down from the board for a period of one year. She, and he, assured the membership his service to the association and to the industry would continue.

New Application Submission Portal and Redesigned Website

The National Maritime Center (NMC) officially launched its new online Application Submission and Additional Information Portal (ASAP) and redesigned website on Monday January 26, 2026. The transition to the new website will begin Friday, January 23, 2026, and users will experience a period of system unavailability during this transition.

Please note this new functionality is not associated with the ongoing development of the U.S. Coast Guard Navita© system. It is a separate effort to improve customer service until the U.S. Coast Guard Navita© is fully operational.

What's Changing on January 26, 2026:

1. ASAP – Fast. Secure. Convenient.
 - Submit merchant mariner credential (MMC) applications.
 - Submit medical certificate (MC) applications.
 - Upload supporting or additional documents for existing MMC or MC applications.

To help mariners prepare for the transition, a step-by-step tutorial demonstrating how to use ASAP is available. Mariners are strongly encouraged to review the tutorial in advance of the January 26 launch.

Prepare Now: [ASAP Tutorial](#)

ASAP will be the primary method for submitting applications and additional documents for new and existing applications to the NMC. Submission options such as e-mail or fax will be significantly limited and eventually discontinued as part of this transition.

2. New and Improved Website – Clear. Simple. Customer-first navigation.
 - Improved navigation and layout.
 - Clearer “How to Apply” guidance.
 - Easier access to credentialing information and customer support tools.

These improvements are designed to simplify the process, reduce waiting times, and give you more control over your documents.

C-PORT reached out to NMC prior to the site going live. CAPT Drayer commented that as use of the system proceeds, NMC is creating a FAQ document that will be available to answer some of the most commonly asked questions. 
CAPT Matt Fine, Chief, Office of Shore Forces USCG, provided Office of Shore Forces, Coast Guard staffing and Command Center updates. He thanked C-PORT and its members for the assistance provided to CG Command Centers and Stations. He noted that cooperation and engagement are the "backbone of our relationship".

He noted that policy and procedures for state and local agencies not tied to CG/MSAP policy may be challenging to the industry. Keeping open lines of communication and working with shore partners is critical with the changing maritime landscape.

CAPT Fine provided notes from CG-SAR. The Coast Guard assumed leadership of the Search and Rescue Satellite Aided Tracking (SARSAT) program for the U.S. Government. This culminated a 5-year effort coordinated with NOAA, NASA, and the Air Force.

He advised the CG SAR Addendum is undergoing a substantial revision in both form and function. Fine stressed that the revision will enhance training and operations for CG SAR and the spirit of the Maritime SAR Assistance Policy (MSAP) will remain unchanged.

Later that day, CAPT Fine graciously accepted to present the AFRAS C-PORT Lifesaving Award to two C-PORT members when flight cancelations prevented RADM Jim Olson, USCG (Ret.) from attending the C-PORT Awards Banquet Gala.

39th C-PORT Conference and Membership Meeting Recap

The sessions continued with Starkweather & Shepley Insurance Brokerage presenting Contractual Risk Transfer. The important topic of Contractual Risk Transfer has come up quite a bit in the past year and C-PORT was pleased that they agreed to talk about this issue at the conference. The panel consisted of Jay Frechette, Senior VP, and Sara Mariani, Account Manager, Marine Practice Group at Starkweather. Leading the discussion was Charlie Pugliese, Marine Consultant for Starkweather, and former President and Practice Leader for Travelers Ocean Marine. Tina Cardone, executive director, and Phil LeBlanc provided the C-PORT Government and Legislative Affairs Committee Report and the Programs and Education Report:

Cardone reported that two Coast Guard advisory committees, NMERPAC and NTSAC did not meet in 2025. She stated that these committees provide CG valuable industry perspective for consideration as they improve processes and policies and create regulations. We remain hopeful the work of the committees will start again in 2026.

She continued by addressing the many partner relationships C-PORT has cultivated over the years to promote the marine assistance industry. Discussed were NASBLA, National Association of Boating Law Administrators, and C-PORT's relationship with the NASBLA BOAT program, with Phil LeBlanc holding the industry seat on the program board. Courtney Livingston, NASBLA BOAT Program Director, said a few words on behalf of NASBLA.

ASA, American Salvage Association, and C-PORT have been working together over the last decade on issues that crossed both groups. In 2025, C-PORT and ASA signed a partnership agreement, formalizing the relationship. Katie Hill, ASA Director of Operations, was in attendance.

AFRAS, Association For Rescue At Sea, held its 50th Anniversary Awards Ceremony in Washington DC, on January 13, 2026. Cardone was honored to receive a shout out from Joe Re, AFRAS President, and to hear him speak about the lifesaving contributions of C-PORT members.



AFRAS celebrated two C-PORT members with its prestigious lifesaving award at the 39th C-PORT Conference held January 26–28, 2026 at the Wyndham Lake Buena Vista Resort, Orlando, FL. The award was announced on Tuesday during the C-PORT Awards Banquet Gala.

Honored were Captain Michael Tucker, Big Water Cowboys/TowBoatU.S. Lake Texoma, and Captain Zach Baxter, Estrada Marine Service/TowBoatU.S. Lake Lanier.

RADM James Olson, U.S. Coast Guard (Ret.), AFRAS Board member, was slated to present, but the winter storm made that impossible, grounding flights around the country. CAPT Matt Fine, Chief, Office of Shore Forces, USCG, was at the event and graciously agreed to present these lifesaving awards to the honorees.

RADM Olson sent his congratulations stating, “The Association for Rescue at Sea, AFRAS, promotes the importance of maritime safety with support and award recognition for outstanding rescues and assistance. AFRAS works with many maritime and aviation organizations in the United States and Internationally. AFRAS provides worldwide support and assistance to volunteer air and sea rescue services. As an AFRAS Board member, I am proud to congratulate your two Association for Rescue At Sea award winners this year, Captain Zach Baxter from Estrada Marine Service, and Captain Michael Tucker from Big Water Cowboys, and his deckhand Elie Karam.”

RADM Olson summarized their heroism in a statement supplied to C-PORT:



Captain Baxter saved the lives of 7 people and prevented additional injuries and damage through his courageous actions, skill and singular determination, all the while ignoring the personal dangers that he faced. By acting quickly and decisively, he was able to get 5 children and 2 adults off the burning boat without further injuries or endangering them anymore. He observed the injuries and burns to the victims, and swiftly got them into the hands of shoreside emergency medical teams. Still aware of the burning boat, he returned to the scene and again his expert actions prevented injury to bystanders and damage to nearby boats. Captain Baxter, your quick thinking, exceptional leadership and superb seamanship saved 7 lives and an unknown amount of maritime property. You have my utmost respect. Congratulations on your 2025 C-PORT Award!



Captain Tucker, along with his deckhand Elie Karam, saved 5 lives on Lake Texoma on a day when the weather changed suddenly, and quickly put the lives of those people in extreme danger. Captain Tucker is recognized for his situational awareness, judgement, and seamanship skills under perilous circumstances. His quick decisive actions and calm demeanor under stressful circumstances, saved five lives that day. Additionally Captain Tucker witnessed that post rescue reunion of family and friends. That is indeed a gratifying experience that has few parallels in life. Your persistence, smart marine knowledge and senses, and exceptional boat handling seamanship, saved 5 lives and impacted many more people! You have my sincere admiration. Congratulations on your 2025 C-PORT Award!

Committee Reports, continued

Terry Hill and David LaMontagne, C-PORT board members, discussed special projects and state issues. Hill reported the NENA PSAP- 911 Dispatch Training project is almost done. It has taken years to get to this point, and the final reviews are taking place now. This document will provide a standard and training provided by NENA, National Emergency Number Association, that will be pushed out to participating 911 call centers throughout the country. The purpose of this guidance is to provide for consistent prosecution of all marine cases in the US.

LaMontagne spoke about the importance of establishing and maintaining relationships with local and state agencies, as well as participating in state legislative events. The importance of knowing your legislative representatives is beneficial to your business.

Cardone mentioned a few state advocacy projects C-PORT is working on. C-PORT created a short presentation for use as introduction for local and state agencies and urges anyone in the membership needing guidance or help in relationship development to contact us.

She reported that C-PORT provided state legislative committee testimony in Massachusetts. A bill was introduced to create a buffer around LE activities. Considering the challenges many of our members face doing their jobs without harbormaster interference in MA, C-PORT went on record asking for clarity in the definition of the first responders that this bill would cover, and to specifically include marine assistance towing and salvage responders.

Cardone noted that she and Terry Hill provided a salvage presentation and discussion with the MD Marine Contractors Licensing Board regarding the definitions of maritime salvage and the salvage of structures in marine construction.

Cardone concluded the report by mentioning the numerous federal bills being watched, and highlighting the CG Authorization Act passage that included clear definitions of abandoned or derelict vessels to be used for removal. She forwarded that information to NASBLA and the committee she serves on that is developing a model policy for states to use when crafting their state laws. The definition includes a time element that is necessary to distinguish an abandoned vessel from a vessel in need of salvage services.


Salvage Day in-water demonstrations were canceled due to the sudden drop in temperatures. That didn't stop a morning of insightful sessions.
