# C-PORT held its 36th Conference and Membership Meeting on January 16-18, 2023 at the Hotel Monteleone, New Orleans, LA.

## **Pre-conference meetings:**

The **2023 U.S. Coast Guard and C-PORT Partnership Meeting** was held on Monday morning, January 16, 2023. The C-PORT Board of Directors were honored to welcome RADM Wayne R. Arguin, Jr, Assistant Commandant for Prevention Policy, CAPT Mathew Fine, Chief, Office of Shore Forces, Mr. Jeffrey Wheeler, Deputy Chief, Office of Boat Forces, and LT Eduardo "Eddie" Oropeza, Commanding Officer, CG Station Miami Beach to the meeting. Representing the C-PORT CG subcommittee was Jeff Dziezdic, JDZ Marine, Mystic, CT.

Discussions covered a number of diverse subjects from implementation of subchapter M, credentialing, command centers and i911, and partnerships.



LT Oropeza remarked, "Partnership is great. Relationship is better." Communication between assistance towing operators and their local CG Station is paramount to the success of the relationship.

Continuing with that discussion, CAPT Fine commented that in-person bi-annual sector meetings should be back to pre-Covid times. C-PORT committed to working with our members and Coast Guard to assure these valuable meetings are taking place.

One of the highlighted discussions was the Mariner Credentialing Program (MCP) Transformation. This is a massive IT undertaking with all mariners files being digitized and online processes and procedures being

created to help streamline the credentialing process. The importance of this transformation can not be understated and C-PORT will do its part to help.

**C-PORT Board of Directors held its annual Insurance Partners meeting** on Monday, January 16, 2023. Travelers Ocean Marine underwrites the C-PORT program with Starkweather & Shepley Insurance Brokerage acting as the administrators. Charlie Pugliese, Travelers national practice leader and long time friend of the industry, noted that it has been over 20 years since Travelers stepped up to work with C-PORT in creating an industry specific product that would stand up to the rigors of marine insurance and industry ebbs and flows. Joining the conversation was Mike Burke, Travelers field practice leader, and new to the C-PORT program group from Travelers, Nicole Fox, account executive officer and Scott O'Connor, managing director. 

C-PORT presented its U.S. Coast Guard panel discussion on Tuesday morning. The session was opened by Rear Admiral Wayne R. Arguin, Jr. RADM Arguin serves as the Assistant Commandant for Prevention Policy, and is responsible for the development of national policy, standards, and programs promoting Marine Safety, Security and Environmental Stewardship. The admiral spoke to issues of concern in the industry today, from vessel inspections to credentialing.

CAPT Mathew Fine, Chief, Office of Shore Forces spoke on behalf of Shore Forces and SAR. In his current assignment, Captain Fine is responsible for identifying and filling capability gaps across the Shore Forces Enterprise. This includes Coast Guard Sectors, Vessel Traffic Services (VTS), Aids to Navigation Units and Small boat Stations. He noted that the Coast Guard is also experiencing personnel shortages like the rest of us. New technologies such as i911 and RapidSOS are helping, but local partnerships and communication with C-PORT members has never been more important.



CAPT Fine provided remarks prepared by the Office of Search and Rescue who were unable to attend. With many new operators in the audience, SAR reminded the group of their mission: Minimize the loss of life, injury, property damage or loss, by rendering aid to persons in distress and property in the maritime environment. Cooperation and engagement are the backbone of the relationship with industry providers, and the national MOU and C-PORT participation sets the stage.


#### CONFERENCE RECAP



Mr. Jeffrey Wheeler, Deputy Chief, Office of Boat Forces, and LT Eduardo "Eddie" Oropeza, Commanding Officer, CG Station Miami Beach shared the stage. The Office of Boat Forces enables mission performance in support of the strategic goals of the Coast Guard, providing human capital and capabilities necessary to effectively operate boats to meet Coast Guard mission requirements. Mr. Wheeler explained that the Boat Forces System includes stations, ANTs, marine safety units, sectors, security and response teams, strike teams, cutters, and more. As a retired Chief Warrant Officer, Jeff remembered the early days of the assistance industry and the growing pains as both groups grew and created this partnership.



LT Oropeza, as Commanding Officer, is responsible for search and rescue, protection of one of the largest cruise ship terminal, and the interdiction of illegal flow of narcotics and undocumented non-citizens in the South Florida area of responsibility. He is the Coast Guard liaison to the NASBLA BOAT Advisory Board. LT Oropeza echoed that Coast Guard is experiencing staffing shortages, and called upon the industry to build relationships with their local stations. He reminded everyone that the time to first meet your partners is not at 2 AM during an emergency, and encouraged the membership to visit their local stations and introduce themselves.

#### CONFERENCE COMMITTEE REPORTS

C-PORT convened its 36th Business Meeting on

Tuesday afternoon, January 17, 2023. Tina Cardone, C-PORT executive director, gave the Government Affairs committee report.

A number of task statements were issued to the Coast Guard Advisory Committees that directly influence regulations pertaining to the assistance towing industry. C-PORT is an active participant with two of those advisory committees, NMERPAC, National Merchant Marine Personnel Advisory Committee, and NTSAC, National Towing Safety Advisory Committee. These committees provide CG valuable industry perspective and insight for consideration as they improve processes and policies and create regulations.

Issues and tasks for the committees include, mariner

workforce issues and modernizing the credentialing process. Both committees are tasked with versions of these issues, and C-PORT is providing input on behalf of its members.

Mariner Workforce Issues: NMERPAC is asked to recommend methods to address the shortages. Discussions to date have included booths at job fairs and maritime options for consideration in schools. The goal is to get more people interested in this work and to make it attainable.

Mariner Credentialing Program (MCP) Transformation: Development of a comprehensive IT system that replaces the aging database. It is part of a larger multi-pronged transformation effort coordinated over multiple years to achieve its goal. NMERPAC is tasked to provide recommendations to CG throughout this transformation process. Discussion has included everything from the application process, creating an interactive online process, to individual mariner logins and portals.

Towing Vessel Industry Forecast: NTSAC was tasked with reporting on anticipated challenges expected to impact the towing industry. This was a comprehensive report and was broken into 5 categories: Infrastructure; Crewing; Regulatory; Operating Costs; and Security. Items identified that the speak directly to the assistance towing industry included:

Availability and Maintaining Crew:

- Shift in work life balance
- Generational shift
- Experienced hires versus number retiring including those lost during Covid (physically and who left the industry)
- Credentialing issues
- Drug testing policies in particular use of marijuana; recommendation to move from a test that measures use to a test that measures impairment.

Regulatory concerns:

- Emissions- tier 4 engines for retrofits in older vessels.
- States pre-emption of Federal regulations creating a patchwork of rules.

#### CONFERENCE COMMITTEE REPORTS

*C-PORT attended the NASBLA*, *National Association of Boating Law Administrators*, conference in Manchester, MA in September. Phil LeBlanc, C-PORT Chairman and Tina Cardone, executive director presented the C-PORT position paper on crafting "Slow Down" laws to the NASBLA membership. The assistance towing industry is under federal admiralty jurisdiction. We support safety and wanted to find a way to help states craft state laws that wouldn't conflict with federal law and create unintended consequences for the industry. C-PORT offered this position paper as a way to work with the states to achieve those goals.

Terry Hill, Potomac Marine and past C-PORT Chairman, continues his work on with NENA, National Emergency Number Association, in creating policies and procedures for 911 call centers to use when dealing with a maritime call. The committee disbanded during Covid and was reestablished late in 2022.

C-PORT follows numerous legislative actions throughout the year, and are ready to act on any and all issues that may be challenges or opportunities for the industry. We also represented the membership at a number of advocacy events throughout 2022. These included California Boating Congress, Sacramento CA, American Boating Congress, Washington DC, and American Salvage Association annual meeting, New Orleans LA.

Programs and Education and Membership Committee reports were given by Phil LeBlanc. C-PORT strives to bring programs and education to the membership promote professionalism and good business practices.


Marine Assistance Company Operations Guideline was reviewed with an eye to making the template easier for C-PORT members to use and updated recommendations for implementation is sent with the guidance document.

Risk Management Course Library continues to grow. The last edition was Operational Risk Management- The Human Factors, conducted in cooperation with USCG Office of Boat Forces. A new best practices module was presented during the conference and will be available online in the near future.

C-PORT held a BOSAR course in Marblehead OH during April. It was hosted by Jake Dunfee at Rescue Marine. This course is taken directly from the USCG Boat Forces training manual and certified by NASBLA as part of their national standard of training. Thanks to Dunfee's partner relationship with his Coast Guard Station, the participants were able to run patterns and work directly with CG during the training.

#### CONFERENCE COMMITTEE REPORTS

The Maritime Law Association (MLA) held its spring meetings in New York City in May. Tina Cardone represents C-PORT as an MLA member and is on the MLA Salvage Committee. Two cases involving the assistance towing industry were discussed. One involved a salvor's responsibility to be diligent when executing a contract and the other dealt with salvage versus towing.

The Ft Lauderdale Mariners Club Marine Insurance Seminar was held in Ft Lauderdale in October. Tina Cardone is a past skipper of the club and attended with Phil. LeBlanc and Chris Shaffner. Over 500 marine insurance and attorney professionals attended including representatives from our industry. Sessions of interest included Jones Act crew claims and crew shortages and untrained personnel.

Association For Rescue At Sea, AFRAS, Awards Ceremony was held in Washington DC in November. Phil LeBlanc and Tina Cardone received invitations to attend and represent C-PORT. We were honored to have AFRAS acknowledge Greg Giggi, Allwater Marine Services, TowBoatU.S. Charleston, the C-PORT AFRAS 2021 award recipient, from the podium in front of the distinguished guests.

C-PORT encouraged member support of the BoatU.S. Foundation's campaign to be awarded substantial funds from NOAA for distribution and use on debris cleanup on our coasts. We supported BoatU.S. Government Affairs asking for reasonable protections for the North Atlantic Right Whale population. Currently C-PORT is collaborating with BoatU.S. Public Affairs to provide reasonable messaging regarding the potential for unintended consequences of the crash software found on iPhones and through a number of apps.

The C-PORT Mentor Program launched in 2022. These topic specific, virtual sessions have been well received by new members and old members alike. They are held the second Tuesday of the month and are casual, roundtable style discussions with a facilitator and then open questions and answers. Salvage reports, disaster prep, equipment tips, training, have all been topics. C-PORT looks forward to continuing this valuable member benefit.





The Conference of Professional Operators for Response Towing, C-PORT, held its Membership Meeting on January 17, 2023, during the 36th C-PORT Conference. The meeting was held at the Hotel Monteleone, New Orleans, LA. Along with committee reports and industry issue discussions, the membership elected its 2023 C-PORT board of directors.
